## **Trustees Report**

The Trustees have pleasure in presenting their report for the year to 31 July 2020

#### **Structure Governance & Management**

Prison Fellowship Scotland ("PFS") became a Scottish Charitable Incorporated Organisation ("SCIO") on 26 May 2015 under the charity number SC002222. The Trustees elected to convert from a charitable trust to a SCIO in order to bring the structure of PFS into line with current Charity Law applicable in Scotland. The new SCIO replaced the earlier Trust which had been in existence for over 30 years.

Trustees come from a range of backgrounds including Christian ministry, social work, education, prison service and business. New trustees are appointed by the Board of Trustees having taken into consideration their relevant experience. The Trustees meet approximately 4 times per year both face to face and remotely. These meetings address issues such as strategy, engagement with the prison authorities, progress reports, personnel, and finance. Day to day control of PFS activities is undertaken by the Executive Director.

PFS is affiliated to Prison Fellowship International ("PFI"). PFI is a Christian ministry based in Washington DC and exists to serve and support the development of effective national PFI ministries around the world. PFI provides on-going strategic guidance and input into the activities of PFS through a variety of programmed initiatives and support services. As a full member of the PFI community, PFS makes an annual contribution of 6% of its unrestricted income in support of the work of PFI. The Trustees consider the affiliation to PFI as being helpful to the work of PFS and the Trustees acknowledge and appreciate the on-going support and guidance received from PFI and affiliated organisations in Europe.

We welcomed Shirley Berry onto the Board of Trustees in February 2020. Shirley was known to us through a previous management role within Bethany Christian Trust and has provided mentoring services to the staff of PFS. Shirley brings excellent strategic skills as well as pastoral wisdom and charitable organisational insights.

In October 2019, the Trustees were delighted to appoint a new Executive Director, John Nonhebel. John brings an extensive background in faith-based charity management both in the UK and overseas.

#### **Primary Objective**

PFS is a non-denominational Christian organisation working with prisoners, victims, ex-prisoners and their families. PFS operates as a resource to prison chaplains via our volunteer network. Our primary objective is to: "Offer Hope to Prisoners, their Families and our Communities"

To meet this primary objective PFS has six key objectives:

- 1. Recruit and train volunteers to work alongside chaplains;
- 2. Help men and women in prison to explore the Christian faith;
- 3. Deliver a variety of Christian events in the prisons throughout Scotland;
- 4. Promote and deliver Victim Awareness / Restorative Justice courses;
- 5. Care for prisoners, ex-prisoners and their families; and
- 6. Engage with government to promote Biblical standards of Justice.

All the above is underpinned by local prayer groups throughout Scotland.

#### Achievements, performance in 2019/20 and plans for the year ahead

#### Principal activities in the year ended 31<sup>st</sup> July 2020

2019/20 marked 39 years of service for Prison Fellowship Scotland. This was marked at our Annual Gathering in May 2020 that was held online due to COVID-19 restrictions. We welcomed over 70 participants from across our network of volunteers and churches as well as chaplaincy representatives from the Scottish Prison Service.

Prior to the COVID-19 restrictions, our weekly Fellowship groups, Sycamore Tree courses and Sunday service support made PFS volunteers a common sight in the Scottish Prisons, with PFS being in one prison or another on most days. PFS group leaders are supported by the full-time staff and in return they oversee/support our volunteers. We collect monthly statistics on each location in terms of volunteer engagement, prisoner attendances and the number of purposeful, out of cell activity hours. We also encourage regular reviews amongst the individual groups with either a member of staff attending to offer support.

PFS works closely with Chaplains, supporting them in different aspects of Christian service within the SPS ("Scottish Prison Service") estate. PFS also liaises closely with the SPS Chaplaincy Advisors and our formal partnership agreement with SPS ensures our work is done in a way that supports the overall work of SPS in their goal of 'Unlocking Potential and Transforming Lives'.

**Outcomes:** (Note: Since March 2020 our activities have been severely impacted by COVID-19 restrictions)

#### Weekly conversational groups

PFS runs groups for men and women in prison to explore faith as the means to consider a new future and the motivation to achieve it. These groups are provided at least once a week and in some prisons three or four times a week, adding to and complementing the work of Chaplains.

In 2019/20 in these groups alone, we delivered over 8,835 hours of purposeful activities for all categories of prisoner. Unfortunately, the COVID-19 lockdown saw all activities cease. We did however get a few opportunities to go and serve the prisoners spiritual needs in a handful of locations, ensuring risk management processes were in place and social distancing observed in line with the prisons' policy.

#### Sycamore Tree: restorative justice / victim awareness course

In January 2020 PFS hosted a two-day training event for Sycamore Tree Course facilitators with 16 new facilitators trained from within our volunteer base, giving us increased capacity to deliver Sycamore across the SPS estate as well as reviewing the effectiveness of the course material.

#### Currently:

- HMP Low Moss & HMP Grampian run Sycamore throughout the year;
- HMP Inverness runs Sycamore when the need arises and has capacity within the local PFS group;
- Sycamore in HMP Edinburgh commenced at the invitation of the new Chaplain, Gordon Pennykidd, in 2019/20, recruiting and training a new team of PFS Volunteers specifically for HMP Edinburgh; and
- A two-day Sycamore Course specifically for HMP Castle Huntly was delivered.

Sycamore Tree accounted for a further 804 hours of purposeful prisoner activity in 2019/20 and is recognized as a positive indicator of prisoner progression within the prisons.

#### Children's Adventure Holidays

Our collaboration with Circle Scotland and SU Scotland to provide adventure holidays for the children of men and women in prison has been hugely successful in prior years with over 260 young people enjoying an adventure holiday. Unfortunately, the COVID-19 restrictions meant SU holidays did not go ahead in 2020.

#### Angel Tree

PFS provides Christmas presents for the children of men and women in prison each year. This programme is run along with the family liaison units of the jails and gives further opportunity of building relationships with prisoners. During Christmas 2019 we provided over 1,400 gifts across 14 of the 15 Prisons.

#### Letter writing

Prison Fellowship Scotland is in the process of starting a letter writing programme "A Time to Write" where volunteers will be trained to write regular letters (normally monthly) to prisoners in the Scottish jails who have expressed an interest in corresponding with a Prison Fellowship volunteer. This is in response to a recent study which showed that over 50% of prisoners over 50 years old have no outside support. This will provide a new opportunity for our volunteers to continue to work with prisoners. Our aim is to work with prison chaplaincy to be able to identify prisoner participants and refer them to PFS who will then match them up with an appropriate volunteer letter writer.

#### **Volunteers**

We continue to recruit and train our volunteers and currently we sit at around 120 volunteers with another 24 currently at various stages of progress. We continue to attract volunteers from all denominations, ages and backgrounds with a significant increase in younger volunteers enquiring about our work.

Since August 2019 we have grown as follows:

• 14 Sycamore Tree Course facilitators, up eight from last year;

- We have a new team of four volunteers in HMP Edinburgh doing Sycamore Tree and Recovery work;
- We have 21 applicants for our letter writing programme, 14 of whom are new to PFS;
- We have a new prayer group with two volunteers in Dumfries;
- We have had a record year for enquiries, 47 in total.

#### **Prayer groups**

Prison Fellowship Scotland is fortunate to have faithful supporters who are committed to praying for the work. During the COVID-19 pandemic many supporters have joined online prayer meetings. In March 2020 we set ourselves the goal of having local prayer groups linked with each of the 15 prison in Scotland. This goal has been hindered by the pandemic, but we do have small prayer groups linked with 6 of the 15 prisons with work ongoing to set-up groups for the remaining prisons.

#### **Throughcare**

PFS work is with men and women in prison and this brings into sharp focus the need for throughcare support for men and women leaving prison. we liaise closely with other support agencies including Connect to the Community (C2C) to provide friendship and practical support.

We also now have two full-time staff from Glasgow City Mission volunteering with us, this will help keep local prisoners aware of what support is available to them upon release and can be coordinated in advance of a prisoner's release into the community.

#### **Administration**

PFS has now implemented a new volunteer/stakeholder database as well as refreshing our website and MailChimp systems to better retain, communicate with and analyze our stakeholder's details and communication preferences. The new PFS website design will assist with clearer communication channels to our supporters and stakeholders.

#### **Financial Information**

Total income amounted to £60,887 of which £29,053 was restricted to particular purposes. Total expenditure amounted to £79,325 of which £32,358 related to purposes for which the restricted income was earmarked.

The operating deficit for the year amounted to £18,438 reflecting the challenging fundraising conditions that PFS along with many charities across the voluntary sector are currently facing as well as the associated higher expenditure from the expansion of activities and employed staff at the PFS office.

During the year, £3,000 was donated to other organisations working in partnership with PFS who are aligned with our goals and objectives with further payments to be made later in 2020. The sum of £1,901 will be remitted to PFI later in 2020 in support of its work.

#### Risk Management

The Trustees regularly review the risk profile of PFS. In particular, the Executive Director maintains an ongoing dialogue with SPS and the Prison Chaplaincy Service to ensure compliance with all necessary procedures and protocols that may apply to PFS volunteers operating within the prison estate. This is of the utmost importance and is addressed at the periodic meetings of the Trustees. Other risks impacting on the activities of PFS are also addressed at this time.

#### **Investment Powers**

In accordance with the Trust Deed, the Trustees have powers to acquire and sell investments and hold them in a nominee name. However, at this time PFS has no investments to administer.

## **Statement of Trustees Responsibilities**

The law applicable to Charities in Scotland requires the Trustees to prepare Financial Statements for each financial year, which give a true and fair view of the state of the charity's affairs and of the surplus or deficit for the year.

In preparing those financial statements, the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to assume that the charity will continue in operation.

The Trustees are responsible for keeping proper accounting records, which disclose with reasonable accuracy at any time the financial position of the Fellowship and to enable them to ensure that the financial statements conform with The Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 and the Charities Accounts (Scotland) Regulations 1992. They are also responsible for taking such steps as are reasonably open to them to safeguard the assets of the Fellowship and for the prevention and detection of fraud and other irregularities.

The Trustees confirm that all the above requirements have been met.

#### **Notes to the Financial Statements** *for the Year Ended 31 July 2020*

#### 1 Accounting Policies

#### **Basis of Accounting**

The accounts have been prepared on an income and expenditure basis and are in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The accounts also comply with the "Charities Statement of Recommended Practice" using historic cost basis accounting principles.

#### **Unrestricted Fund**

The unrestricted funds are applied by the Trustees in the furtherance of the charity's charitable objectives.

#### **Restricted Fund**

This fund constitutes money provided to the Charity by external donors for specific projects or expenditure.

#### Donations, legacies and similar incoming resources

Donations, legacies and similar incoming resources are included in the year in which they are received. No such funds existed during the period covered in these accounts

#### **Fixed Assets**

Fixed Asset purchases are fully expended to the Income & Expenditure account in the year of purchase. Fixed Asset sales proceeds are treated as General Income at the time of disposal.

#### 2 Payments to Trustees

Trustees receive no remuneration during the year. Trustees were reimbursed £821 for expenses incurred in the course of PFS activities.

#### 3 Charter Fees

Charter Fees payable to PFI have been calculated at the rate of 6% of Unrestricted Income. These monies go to support PFI ministries in other parts of the world. PFS is due to pay the sum of £1,901 to PFI in respect of our affiliation for the period ended 31 July 2020.
